To Whom It May Concern:

AlloSource, a tissue bank with headquarters in Centennial, Colorado, is the holder of a Tissue Bank License in the State of Florida, issued by the Agency for Health Care Administration (AHCA), Division of Health Quality Assurance. The current license# 33, Certificate# 1430, shows an expiration date of 08/19/2020.

On March 9, 2020, Governor Ron DeSantis of Florida signed Executive Order 20-52, which declared a state of emergency in Florida, and permitted the AHCA to grant extensions of licensure for which they have jurisdiction. See Section 4.B. of Executive Order Number 20-52. As a result of this Executive Order, the AHCA extended the validity of AlloSource's Tissue Bank License for three months to 11/17/2020.

Due to continuing COVID-19 restrictions, AlloSource's license renewal remains in process with the AHCA. It will be in an "In Review" status starting after the extension expiration date of 11/17/2020. As stated on the attached letter from the AHCA, **the license will not expire, but the license status will be changed to "In Review" during this application review period.** The "In Review" status can be verified by searching for "AlloSource" on the website documented on the Tissue Bank License, with the link provided below.
